### Conference fee / Scope of service

The conference fee for the FACHTAGUNG ABBRUCH 2025 is **420,00 € per attendee (plus 19 % VAT)**. **For DA-Members the conference fee amounts to 380,00 € per attendee (plus 19% VAT)**. In the conference fee included are:

on Friday, 14<sup>th</sup> of March 2025:

- Attendance at the presentations and the accompanying exhibition at STATION-Berlin
- Coffee breaks, conference beverages, and lunch at STATION-Berlin
- Attendance at the Dialogue Evening including catering at STATION-Berlin
- Full-day free shuttle bus service between the Hotel Berlin, Berlin by Radisson Individuals and the venue, the STATION-Berlin from 07.30 a.m. until 11.00 p.m.
- Download of conference documents, possible shortly after conference ending

### Obligations of Attendees

The organizer is entitled to deny access to the conference and Dialogue Evening to people, who do not wear this name badge and admittance bracelet. This does not result in any claims for compensation.

Any further access requirements that may become necessary remain reserved.

If, in the context of unpredictable events, administrative restrictions or even prohibitions are imposed – possibly even at very short notice – that change the obligations of the attendee/participant under these “Terms and Conditions – Attendees” and thus, if necessary, other, extended obligations become necessary, the attendee/participant insures them according to precise information by DA Service GmbH, to accept and implement accordingly.

## Terms and Conditions – Attendees

### Registration / Conference website / Registration deadline

The registration as an attendee of the FACHTAGUNG ABBRUCH 2025 needs to be completed **online via the conference-website [www.fachtagung-abbruch.de/en](http://www.fachtagung-abbruch.de/en), rubric “Attendees”**. **Registration deadline is Friday, February 21<sup>st</sup>, 2025**. Late registrations may be accepted depending on the capacities available. For late registrations the organizer needs to be contacted ahead.

### Terms of payment / Invoicing

Invoicing is issued in January 2025 by DA Service GmbH. The amount invoiced needs to be paid by bank transfer immediately after receiving the invoice. **It is mandatory to make the payment to the organizer’s account before March 14<sup>th</sup>, 2025**.

### Cancellation of registration

All cancellations of attendees must be made in writing and have to be reconfirmed by DA Service GmbH to be legal effective. For cancellations within the scope of FACHTAGUNG ABBRUCH 2025 the following regulations apply contrary to the terms and conditions of DA Service GmbH: In the event of a written cancellation by the participant before **14<sup>th</sup> February 2025** (date of receipt by the organizer), all payments made will be refunded in full. For cancellations received by the organizer after **14<sup>th</sup> February 2025**, there is no refund possible. Representation of a registered participant by another person is possible at any time. If the name of the representative person should appear in the list of participants, it is necessary that the name will be given to the organizer in writing not later than **21<sup>st</sup> February 2025**.

### Accommodation

The organizer has made reservations at special rates for both nights - March 13<sup>rd</sup> until March 15<sup>th</sup> 2025 at the Hotel Berlin, Berlin by Radisson Individuals. There will be a free shuttle service from Hotel Berlin, Berlin by Radisson Individuals to STATION BERLIN and back at the day of the conference, March 14<sup>th</sup> 2025 from 7.30 a.m. until 11.00 p.m.

### Disclosure of attendee’s data / Possibility to refuse the disclosure

Data given in this list are the attendee’s first and last name, the company’s name as well as postal code and location.

### Name badge

During registration for the FACHTAGUNG ABBRUCH 2025 the organizer will hand out a name badge to each participant, which needs to be worn to access the conference.
